Resolution No. 2019-2

A Resolution Approving the Comprehensively Revised St. Croix County
Zoning Ordinance

WHEREAS, the Town of Cady desires to promote the health, safety, convenience and general welfare of the residents of the Town and to encourage planned and orderly land use and development; and

WHEREAS, The County Board of St. Croix County, Wisconsin has adopted a comprehensive revision of the zoning ordinance for the physical development and zoning of land within St. Croix County; and

WHEREAS, The St. Croix County Zoning Ordinance may become effective in the Town of Cady upon approval of the ordinance by the Town Board.

NOW THEREFORE, BE IT RESOLVED that pursuant to Section 59.69(5)(c), Wisconsin Statutes, the Town Board of Cady approves the St. Croix County Zoning Ordinance (Chapter 15 of the St. Croix County Code of Ordinances) as described in St. Croix County Ordinance No. 881 (2019) and shall take all required actions to make the St. Croix County Zoning Ordinance applicable within the Town of Cady.

This resolution shall take effect on the date of filing with the St. Croix County Clerk a certified copy of this resolution, together with a copy of the comprehensively revised St. Croix County Zoning Ordinance.
